

Common European Framework of Reference for Languages: Learning, teaching, assessment (CEFR)

Summary of scaled descriptions of the competences

Note: To take full advantage of the immersion in Pueblo Español, our minimum recommendation is having mastered A1 and A2 grammar, vocabulary and structures and going on to a B1 level.

The grey areas do not refer to speaking or listening comprehension, so they are not necessary for this immersion course.

This is a summary of scaled descriptions of the language competences (understanding, speaking and writing). The Common European Framework of Reference for Languages: Learning, teaching, assessment (CEFR) describes foreign language proficiency at six levels, and provides a common basis for the elaboration of language syllabuses, curriculum guidelines, examinations, textbooks, etc. in 40 languages across Europe. It is the result of over 20 years of research and it describes in a detailed manner what language learners have to learn in order to use a language for communication and which knowledge and skills have to be developed in each of the different levels which are clearly defined and measured. It also mentions the cultural context in which language is learned. Pueblo Español has used the CEFR to define the activities and schedule and apply it to its methodology.
